Even though the government did not concede the issue, it obviously held the opinion that the government's evidence of voluntariness was sufficient to sustain the jury's verdict. As such, it would be wholly inconsistent with the position of the government to hold that even if the government's evidence was insufficient to convince the trial court that the statements were involuntary, it was sufficient to support the jury's verdict. The position taken by the government in this case, that the trial court should have decided the issue of voluntariness itself, thus is untenable. But assuming that the government's initial position was correct, the record demonstrates that the trial court reconsidered its ruling and placed the voluntariness issue before the jury and that the trial court then found that the statements were voluntary. 29 The district court's finding that the evidence on the issue of voluntariness was "overwhelming" provides little support for the trial court's decision, in view of the contrary evidence presented by the government. In light of this conflicting evidence, the district court's conclusion was based on a clearly erroneous finding of fact, and the district court abused its discretion. United States v.
